1. General Product Description

MoliCare Skin cleansing foam, contains creatine, supports the skin's own protection mechanisms. Odour-neutralising, skin-neutral pH.

2. Application / Indication

For quick, gentle cleansing of persons suffering from incontinence.

Shake well before use. Spray directly onto the affected area from a distance of about 20 cm, allow to soak in quickly and wipe away without using soap and water.

Observe aerosol safety instructions.

5. Classification/Safety Aspects

In the Federal Republic of Germany MoliCare Skin Cleansing Foam is classified as cosmetic product. The product is in compliance with the latest amendments of the European Directive on Cosmetics (EEC Council Directive 76 / 768 with Technical Adaptations and Amendments). The product contains only ingredients which are permitted resp. which are not prohibited for cosmetic use according to the EEC Directive on Cosmetics.

The skin tolerance was dermatologically tested on predamaged (scarified) skin of human subjects with the result "good to very good" as well as on persons with atopic dermatitis in eczema free intervall with the result "MoliCare Skin Cleansing Foam was tolerated well in all subjects". Combined with a protective product of the MoliCare Skin series the Cleansing Foam was tested in a nursing home on persons suffering from incontinence under supervision of a medical specialist. The combined application of the products resulted in an improvement of the skin condition. Furthermore the very good skin tolerance was attested.
