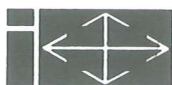

are fulfilled as well. Instead of the not yet evaluated Technical Document 1 on constituents, the list of fabrication additives of the German Recommendation XXXVI was consulted.

Thus the Blue and White Airflex<sup>®</sup> Hand Towels code 00V according to the sample material submitted may be used safely as hand towels in the food preparation and processing sector. They may come into direct contact with foodstuffs as well as with the human skin and the mucous membranes for a short period of time.

This certificate of compliance has a validity of 2 years and consists of 5 pages.
